



MINOR PROGRAM PARTICIPANT CODE OF CONDUCT

It is our commitment to provide a safe and healthy environment for all minors participating in programs or activities at the university. Minor participants must adhere to our general standards of conduct and expectation of behavior and program rules. It is the responsibility of the parent/legal guardian and the participant to review the program rules and standards of conduct. Minor participants dismissed from a program/even resulting from a code of conduct violation are not eligible for a refund of any fees or expenses. The parent/legal guardian is responsible for all costs associated with removing the participant from the program due to his/her misconduct, including but not limited to transportation costs to return the participant home.

<ul style="list-style-type: none"> Do not engage in harassing activities which include: <ul style="list-style-type: none"> Jokes, comments, or gestures of a sexual nature Indecent exposure of private body parts Unwelcome physical conduct or contact Possession, or sharing, of sexually explicit materials Harassment, teasing, or hazing Any sexual activity 	<ul style="list-style-type: none"> All program minor participants must report any inappropriate comments, behaviors, or actions made by adults/peers to program supervision or by calling 911 if the program supervisor or staff is involved.
<ul style="list-style-type: none"> Bullying in any form is prohibited which includes: <ul style="list-style-type: none"> Gossiping Taunting Name Calling/Racial or Gender Slurs Threats in person or on social media Sextortion 	<ul style="list-style-type: none"> Illegal substances and inappropriate materials are strictly prohibited including: <ul style="list-style-type: none"> Drugs Alcohol Weapons Drug Paraphernalia- Vaping Cartridges Pornography or sexually explicit or inappropriate materials
<ul style="list-style-type: none"> Inappropriate use of electronic devices to bully, harass or intimidate is prohibited 	<ul style="list-style-type: none"> Videotaping, filming or recording in bathrooms, locker rooms, bedrooms and other areas where there is an expectation of privacy is prohibited.
<ul style="list-style-type: none"> Misappropriation of personal belongings of other minor participants is prohibited 	<ul style="list-style-type: none"> Minor participants are expected to follow all emergency procedures and directives as given by program staff and volunteers
<ul style="list-style-type: none"> Do not engage in jokes, explicit comments, insults, inappropriate or unwanted language or comments that are offensive, gender or racially offensive. 	<ul style="list-style-type: none"> Destruction and misuse of university property and materials is prohibited.
<ul style="list-style-type: none"> Do not use social media platforms to harass, intimidate or bully other program participants 	<ul style="list-style-type: none"> Report any unusual behavior by staff or other program participants
<ul style="list-style-type: none"> All minor participants are expected to adhere to program schedules and must be present at all program activities. Unauthorized absences from program activities is prohibited 	<ul style="list-style-type: none"> Notify program staff if you are feeling ill or become sick immediately

I understand that as a condition for participating in the program that I must comply with the program's rules and standards of conduct and follow all reasonable directions of the program staff. Failure to comply with the program's rules and standard of conduct or failure to comply with the reasonable direction of program staff may result in my being dismissed from the Program.
